\* Age limit as shown above is relaxable by 5 years in respect of candidates belonging to SC/ST community and 3 years in respect of candidates belonging to OBC community.

The engagement will be initially for a period of six months which may be extended or curtailed depending on the duration of the tenure of sponsored project/satisfactory performance or conduct of the appointee, as the case may be.
